Sage P11D Professional is for businesses requiring more than 250 reports with network and multi-user needs. It has the following additional features to Sage 50 P11D:

- Batch Processing - save time by using Batch Entry to add a series of benefits of the same type to a number of employees at the same time
- Benefit Templates - avoid duplication and re-entering of similar data across a number of employees by setting up a benefit template
- Class 1A drilldowns - quickly and easily drill down into entries on the Employer's Declaration, form P11D(b), by benefit type and by employee
- Global PSA Benefits - enter details of any company wide benefits upon which a PAYE Settlement Agreement has been reached
- Audit Trail - track changes made in Sage P11D Professional, itemising each time a user logs in and out and changes made to employees and benefits
- Employee Profiles - You can create a set of default characteristics relating to employees and then apply the profile to selected employees. This automatically populates fields in the employees' records, reducing time spent on data entry
- Enhanced Reporting - using Sage Report Designer, you can customise existing reports and create new reports to suit your own business needs

<b>Employee</b>	High Rate tax percentage increased to 50% (incl. PSA report)
<b>Company Cars</b>	<ul style="list-style-type: none"><li>• Company car fuel legislation rates updated</li><li>• Company car legislation rates updated</li><li>• Company car fuel benefit charge appropriate percentage is increased to £18,000</li><li>• Company car appropriate percentage for electric cars down to 0%</li><li>• Removal of list price limit of £80,000</li></ul>
<b>Company Vans</b>	<ul style="list-style-type: none"><li>• Electric vans are now included with a separate charge of £0</li><li>• Fuel benefit charge is increased to £550</li></ul>
<b>Beneficial Loans</b>	Official rate of interest for loans made in pound sterling is reduced to 4%
<b>Accommodation</b>	Official rate of interest for accommodation benefits who cost exceeds £75,000 is reduced to 4%
